I SI Biswajit Biswas of Ashighar OP under Bhaktinagar Police station, SPC do here by lodge a written complainant against Seven (07) accused persons namely (1) Nimai Malakar (28) S/O Shyamal Malakar Of Naresh More C/O Sanjay Shil, PS Bhaktinagar, Dist Jalpaiguri (2) Keshor Alam (30) S/O Kalimuddin Of Jharbari, PS Chopra, Disr Jalpaiguri (3) Tapan Barman (28) S/O Girish Barman Of North Sukanta Nagar, PS Bhaktinagar Dist Jalpaiguri (4) MD Gulzar Alam (21) S/O MD Islam Of Chakand, Mahmoodabad, PS Chakand, Dist Gaya, State Bihar (5) Purna Datta (41) S/O Lt Binod Datta Of North Sukanta Nagar W/No 38 PS Bhaktinagar Dist Jalpaiguri (6) Prodip Das (41) S/O Nonigopal Das Of Ghogomali Bazar W/No 37 PS Bhaktinagar Dist Jalpaiguri (7) Gour Datta (52) S/O Lt Binad Datta Of North Sukanta Nagar W/No 38 PS Bhaktinagar, Dist Jalpaiguri., to the effect that 11.07.2021 at 14.05 hrs myself along with ASI Sumit Baran Nath along with C/ 729 Dinesh Ch Roy and CV- 1034 Manajit Barman while performing patrolling duty in connection with Covid -19 situation at Ashighar OP area vide Ashighar OP GDE no. 312 Date 11.07.2021, at about 15.10 hrs found that the above noted persons were roaming at Ashighar More without wearing Mask and without any purpose which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without any emergency requirement as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock dawn from 16th may to 31th May vide memo no. 647-ISS/2M-22/2020 DT 15.05.2021 and the same has been extended till 15.06.2021 and order no. 753-ISS/2M-22/2020 DT 14.06.2021 and the same has been extended till 15.07.2021 and order no. 754-ISS/2M-22/2020 Dt-28.06.2021 as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duly promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India. I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area

without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.
