W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling And 2] Tumpa Lama (29yrs) W/O Bhupen Gachi of Malbajar Promod Nagar Colony, PS.- Malbazar, Dist.- Jalpaiguri both of RED APPLE SPA LOUNGE UNISEX SALOON AND SPA at City Centre, under Matigara PS 3] Indradeo Paswan (51Yrs) S/O Arjun Paswan of Khagra Pokhar BSF Road, PS+ Dist.- Kisanganj, Bihar and along with following seized articles :

I, Mumtaz Begum, Inspector of Police, Siliguri Women PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the 03 (three) arrested accused persons namely 1] Indradeo Paswan (51Yrs), S/O Arjun Paswan of Khagra Pokhar BSF Road PS+ Dist.- Kisanganj, Bihar 2] Anita Lama (46 yrs) W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling And 3] Tumpa Lama (29yrs) W/O Bhupen Gachi of Malbajar Promod Nagar Colony, Ps.- Malbazar, Dist.- Jalpaiguri to the effect that on 11/7/2021 at 14:15hrs received a secret information over telephone at Siliguri Women PS, SPC from secret source that some prostitution business is going on at RED APPLE SPA LOUNGE UNISEX SALOON AND SPA at City Centre, under Matigara PS Dist.-Darjeeling under the coverage of body massage. Accordingly, the information was diarized vide Siliguri Women PS GDE No-284 Dated 11/07/2021 and myself along with LSI Angela Regmi, LSI Palzam Bhutia, ASI N.C.Roy, ASI Narayan Hela, C/529 Paltan Biswas, L/C 684 Benjir Begum, all of Siliguri Women PS SPC left for RED APPLE SPA, LOUNGE UNISEX SALOON AND SPA at City Centre, under Matigara PS, via Matigara P.S and obtained assistance of the police team from Matigara PS to verify the veracity of information, SI BD Guha, ASI Nitai Mandal, C/ 1008 Kanak Roy, C/ 1035 Sontosh Rabidas accompanied us. On arrival, at RED-APPLE SPA LOUNGE UNISEX SALOON AND SPA at City Centre, under Matigara PS, I called two available local independent witnesses namely 1] Manzil Lama S/O Rinchen Lama of salbari Ambadhura, PS Pradhannagar, Dist.- Darjeeling 2] Kiran Baraik S/O Surjan Baraik of Atal Tea garden, Paka Line PS-Naxal Bari, Dist.- Darjeeling and requested them to remain present during the time of raid, search and seizure if any. Subsequently, we entered into the shop styled as "RED APPLE SPA LOUNGE UNISEX SALOON AND SPA" City Centre, G Block ground floor along with the aforesaid witnesses, we found one female person at reception counter on being asked she disclosed his identity as Anita Lama (46 yrs.) W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling and stated she is the owner of the "RED APPLE SPA LOUNGE UNISEX SALOON AND SPA. We disclosed our identity and explained purpose of our presence at her shop. In presence of witnesses, we search the said RED

APPLE SPA LOUNGE UNISEX SALOON AND SPA. We found one small room made for customers for sexual act and the said room of the SPA was under lock from the inside. Then we knocked the door of the room and when opened, we found one male and female person inside the room in an objectionable position and male was naked and was wearing only half-pant, they were involved in sexual activities. Thereafter with the help of lady police we separated the female from the male person, on being asked by me the female person disclosed her name as Tumpa Lama (29yrs) W/O Bhupen Gachi of Malbajar Promod Nagar Colony, PS- Malbazar, Dist.- Jalpaiguri and further she disclosed that that she has been engaging in the business of prostitution by Anita Lama (46 yrs.) W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling, owner of RED APPLE SPA LOUNGE UNISEX SALOON AND SPA, she was indulged in the business of prostitution for her livelihood and earn money from prostitution. On interrogation said male person disclosed his identity as Indradeo Paswan (51Yrs) S/O Arjun Paswan of Khagra Pokhar BSF Road PS+ Dist.- Kisanjanj, Bihar and he admitted that he was came for his sexual pleasure in lieu of paying money to the owner of the RED APPLE SPA LOUNGE UNISEX SALOON AND SPA, he came here contacted with the owner Anita Lama at reception, she told him they gave sexual pleasure for money and he agreed to pay money, he was taken inside the room behind the counter, thereafter he and Tumpa Lama engaged in sexual activity. On interrogation the owner namely Anita Lama admitted that she along with Tumpa Lama has been carrying the business of illegal prostitution under the camouflage of body massage in a public place i.e. City Centre G Block, Matigara for their monetary benefit and maintain their livelihood on the money which they earn through the business of prostitution under the camouflage of body massage, they also admitted that they meet up the urges for sexual pleasure of customers by demanding extra money and provide them sexual pleasure. Accordingly, we searched the RED APPLE SPA LOUNGE UNISEX SALOON AND SPA, in presence of independent witnesses and found above noted articles and seized under proper seizure list as noted above. Then, I arrested the accused namely 1] Anita Lama (46 yrs.) W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling And 2] Tumpa Lama (29yrs) W/O Bhupen Gachi of Malbajar Promod Nagar Colony, PS.- Malbazar, Dist.- Jalpaiguri both of RED APPLE SPA LOUNGE UNISEX SALOON AND SPA at City Centre, under Matigara PS 3] Indradeo Paswan (51Yrs) S/O Arjun Paswan of Khagra Pokhar BSF Road, PS+ Dist.- Kisanjanj after observing all the formalities of arrest and also informed them the ground of arrest and I brought them to Matigara PS.

Hence, I would like to request you that a specific case under proper sections of law may please be started against accused persons namely 1] Anita Lama (46 yrs) W/O Prabal Bora of Uttarayan HIG PS- Matigara, Dist.- Darjeeling And 2] Tumpa Lama (29yrs) W/O Bhupen Gachi of Malbajar Promod Nagar Collony, Ps- Malbazar, Dist.- Jalpaiguri both of RED APPLE SPA LOUNGE UNISEX SALOON AND SPA at City Centre, G-Block under Matigara PS 3] Indradeo Paswan (51Yrs) S/O Arjun Paswan of Khagra Pokhar BSF Road PS+ Dist.- Kisanjanj, Bihar and arrange for its investigation.
