In producing herewith 07 (seven) arrested accused persons who disclosed their identity as (i) Manish Jindal (22 yrs), s/o - Mahesh Jindal of East Vibekananda Pally, Rabindra Sarani, w/no - 36, PS - Bhaktinagar, Dist - Jalpaiguri (ii) Bieky Roy (23 yrs), s/o - Arun Roy of Bara Kamath, PS- Maynaguri, Dist - Jalpaiguri (iii) Alokesh Roy (25 yrs), s/o - Saibo Roy of West Harimoti, PS- Maynaguri, Dist - Jalpaiguri (iv) Bishnu Roy (31 yrs), S/O - Bhjagindra Nath Roy of Mallarbari, PS- Rajganj, Dist - Jalpaiguri (v) Bhaben Das (33 yrs), s/o - Subhas Das of North Bengal Firm, PS- Rajganj, Dist - Jalpaiguri (vi) Amit Roy (29 yrs), s/o - Subrata Roy of Bara Kamath, PS- Maynaguri, Dist - Jalpaiguri (vii) Rishad Ali (21 yrs), s/o - Yakub Ali of Madarihut, PS- Madarihut, Dist - Alipurduar.

I, SI Kamal Sarkar of Milanpally OP under NJP PS /SPC do here by lodge this written complaint against the above noted persons to the effect that while on performing evening mobile Van duty myself along with officer and forces had been to Teesta Barrage under Milanpally OP at 17:55 hrs and found that the above noted persons are gathered there without any reason and found them without wearing mask. Thereby making unnecessary gathering at Teesta Barrage under Milanpally OP. On being asked the above noted persons stated before me that they were well aware of yesterday's Govt Order regarding pandemic situation of Covid 19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all violated the order of Govt. of West Bengal vide Memo No - 486-CS/2021, Dated - 24/04/2021 & Govt Order No - 647-ISS/2M-22/2021, Dated - 15.05.21. Hence I arrested them u/s - 41 Cr.P.C in c/w the case under proper memo of arrest duly signed by them in presence of witnesses.

Now I request you for starting a specific case U/S-188/269/270 IPC r/w Sec 51(b) of Disaster Management Act 2005 against the above noted accused persons and arrange proper investigation of the case.
