Dear Sir,

With due respect, I Manash Joardar S/o. Monotosh Joardar resident of Vill. Mohit Nagar, P.O. Mohit Nagar, Jalpaiguri, and working as Manager – Boiler Farming Division at Power Plus, having registered office address at No. A41 to A54, Ambari Falakata Industrial Estate, Mogradangi, P.O. – Payachari, Dist – Jalpaiguri, Pin-735135, would like to inform that we have an agreement with Mr. Mritunjay Saha. S/o. Dibyendu Saha resident of Vill. Porhajhar, Dabgram, P.S. – Bhaktinagar, Dist. Jalpaiguri. Pin – 735135 regarding boiler contract farming at Land of Sri. Subrata Sarkar, S/o Sri. Sukhendra Chandra Sarkar, Vill – Pelkavita, P.O. – Kamarvita, P.S. – Bhaktinagar, Dist – Jalpaiguri, Pin – 735135 (Copy Attached). As per the agreement we provide day old chicks, feed and medicine at the farmer's place and we sale the bird after 35 to 45 days and the farmer gets growing charges against his service.

But on 11.06.2021 at 8.30 P.M. our Staff Mr. Mosaraf Hussein (Supervisor), S/o – Mansur Ali, resident of Vill. Pradhanpara, P.O. - Shikarpur, Dist. Jalpaiguri, Pin – 735133 gone for lifting of Ready Bird (Boiler) for sale purpose from both farms and he saw both farms are empty and the farmer was not there, we called him several times but he did not pick up the phone, we have understood that all the ready birds (Boiler) were sold out which approx. market value is **Rs. 7,00,000.00 (Rupees Seven Lakhs Only)** which was the stock of our company and it is a case of theft.

Thereafter we came to know both farms are constructed at above mentioned land by Sri. Amit Kumar Sarkar (Mob No. 96410 71384), S/o – Ajit Kumar Sarkar, Vill – Pelkavita, P.O. – Kamarvita, P.S. – NJP, Dist – Jalpaiguri, Pin – 735135, and Mr. Mritunjay Saha was taking both farms as lease basis.

Now after, we are understood that Mr. Mritunjay Saha (Mob No. 9832697911), and his team of Sri. Amit Kumar Sarkar (Mob No. 9641071384) was conducting a fraud with us and Mr. Amit Kumar Sarkar, his father Mr. Ajit Kumar Sarkar, his mother Mrs. Rina Sarkar doing frauds with poultry Integration companies in the name of their staffs or other associates, submitting false documents for agreement and before the time of sale they sale the birds without asking the concern company. They are using two vehicles (Vide Registration No WB 71B 4755 and another Number provide you later) for this purpose only. We came to know some other person is the master mind of the operation and Mr. Amit Kumar Sarkar is the Leader of the operation.

Hence, we searching our birds many places between 11.06.21 to 20.06.21 but it is not recovered, so we request you to kindly accept our F.I.R. and do the need full for recover our amount of **Rs. 7,00,000.00 (Rupees Seven Lakhs Only)** as soon as possible.

Your kind cooperation in this matter is highly appreciable.
