Respected sir,

I Rajkumar mallick s/o umesh mallick , of airport more gowala busty, P.s Bagdogra , dist Darjeeling , would like to inform you that yesterday night i.e on 12/07/2021, at about 11:30 pm person named i) Pradip mallick s/o late Ramswarup mallick along with him ii) Anjali Paswan w/o bittu Paswan , iii) Manshi mallick d/o Pradip Mallick , iv) Prem Mallick v) Binod Mallick vi) Sunny Balmiki S/o Lala Balmiki all are resident of Salkavita New Rangia near NBU gate no -5, p.s Matigara , Dist. Darjeeling entered in my house by breaking the lock of the door and started hitting me with fists blows and kicks and one person iron rod in his hand hit me on my head from behind and blood started oozing out my head and eye. Then one manshi maliick and her brother Gautam mallick enter in my mothers room and took her out and they started hitting my mother and tore her wearing apparel and try to outrage her modesty. Then they started throwing the articles of my house. then one Vishal Basfore s/o Nathuni Basfore of kestopur open the godrej and took 20,000 rs cash which was kept for the treatment of my father and they started hitting my daughter namely Naina mallick, Chand Mallick and Nibha Mallick and when my child started hue and

crying then people started gathering there after seeing people gathering then they started fleeing away from there and while fleeing they threatened that if we go to police and diarized the said matter they will kidnapped my minor daughter. Then I went to Bagdogra Primary health care and hospital for my treatment. Due to their such assault I received severe injuries on different parts of my body and injury on my head.

So, I therefore request you to kindly take necessary legal action against aforesaid culprits for the commission of the said offence.
