Sir,

I S.I. Agen Lepcha of Matigara P.S do hereby lodge a Complaint to the effect that on 13.07.2021 at 13:05 hrs I received information from reliable source that one Dumper vehicle bearing Regd. No. WB-73-D-3447 loaded with stolen river bed materials coming from Himul side towards Balasan Colony. On receiving the information I along with available forces rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at near Himul Side under Matigara P.S area, I found the said vehicle loaded with river bed materials going towards Balasan Colony by illegal means for wrongful gain. Subsequently I manage to stop the said vehicle and seized the said vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the driver on proper Memo of Arrest and brought to the above noted loaded vehicle and accused person at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle without number plate under proper section of law and arrange for its investigation.
