I, SI Sushanta Dhar of Matigara PS SPC to the effect that on 13.07.2021 during performing Mobile Van duty at near Matigara Bazaar under Matigara PS area he found Six persons namely (i) Kartick Sah (23), S/O Chandrika Sah of BRI Colony, Ward No.1, PS - Pradhan nagar, Siliguri, Darjeeling, (ii) Md. Tamij (23), S/O Lt. Md. Khasibuddin of Rangapani, PS - BDR, Dist - DJG, (iii) Surendra Rai (34), S/O Sudarsan Rai of Saugrampur, PS - Mahaura, Dist - Saran, Bihar, (iv) Ashutosh Vaishali (26), S/O Gopal Prasad Gupta of Ward No. 04, Saur Bazar, Bihar , (v) Jitendar Prasad (24), S/O Moti Chand Prasad of Rangapani, PS - BDR, Dist - DJG were loitering near Matigara Bazar under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Khasibuddin of Rangapani, PS - BDR, Dist - DJG, (iii) Surendra Rai (34), S/O Sudarsan Rai of Saugrampur, PS - Mahaura, Dist - Saran, Bihar, (iv) Ashutosh Vaishali (26), S/O Gopal Prasad Gupta of Ward No. 04, Saur Bazar, Bihar , (v) Jitendar Prasad (24), S/O Moti Chand Prasad of Rangapani, PS - BDR, Dist - DJG proper section of law and arrange for its investigation.
