Sir,

Under the instruction from and on behalf of my client Smt. Madhumita Sarkar W/O- Joy Bisnu D/O-Sri Nirmal Sarkar of resident of Vivekananda pally, Kadamtala P.S -Matigara, Dist-Darjeeling, presently residing at my parental house at Purba Dhantala, Satellite Town Ship, Dist-Jalpaiguri would like to inform you to that our marriage was solemnized on 28.02.2021 at house at Purba Dhantala, satellite town ship, dist.- Jalpaiguri as per Hindu Rites and custom in presence of friends, relative and well-wishers of both parties and per their demand all upodhoukan were given to my husband and mother in law. There after my husband took me in my matrimonial house, Vivekananda pally, kadamtala, P.S-Matigara, Dist- Jalpaiguri, after 5/6 days of our marriage my mother in law along with my husband used to torture my physically and mentally due to want to dowry because my husband is a manager of Royal Enfield workshop, he wants own business. My mother in law and husband scolded me by saying that " amra choto lok, ami choto loker meye, Ami kono kaj jani na, ami jehetu schedule caste tai kono manner jani na, Age schedule caste er meye janle ami amar cheler sathe biye ditam na, Amar Golate onek sctrach mark ache, amar sasuri amake tar nokh diye kete diyeche, Tara jore gaan bajiye marto jate amar chitkar keo sunte na pai, ora amar ghor change kore vetore diyeche jate paray kew sunte na pay, On 28.3.2021 at about 10.30 PM my husband along with my mother in law amake balish mukhe chapa diye marar chesta kore" even one day they implicated severe torture upon me as result I became senseless as a result they admitted e in a nursing home, probably Mukta Nurshing home but all medical papers are their custody. The aforesaid person even scolded me in presence of my parents and relatives for schedule caste. On 10.7.2021 at my husband and mother in law physically assaulted me and next day my husband again kicked me by saying that after return of his office he will kill out of fear in the evening time at about 6. PM on 11.7.2021 fled from my matrimonial house and took shelter in my maternal sister's house at Saktigarh in one cloth. My mother in law snatched my all gold ornaments from me and keeps the same in her solo custody. And all stereedhan properties are still lying their solo custody and control on 11.07.2021 my husband at 7 PM along with 4 person came to our parental house to search me at that time they hurling dirty words towards us as result some pare people asked to my mother in law to come my parental house over phone because at that time I was missing by switch off my cell phone but at the time police came to our parental house and took my husband at NJP P.S subsequently I contact my brother Dipak Sarkar through phone who brought me in my parental house and next date i.e. on 12.07.2021 I got treatment due to
