Sir,

With due respect, I am producing herewith the arrested accused person namely Biplob Mahanta @ Hakar (45 yrs) S/O late Niresh Mahanta of Mamata Para, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 27 (Twenty Seven) bottles of. 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 09.07.21 at 21.05 hrs I received a secret source information that one person namely Biplob Mahanta @ Hakar of Mamata Para, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his residence at Mamata Para under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 445 dated 09.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Pares Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy left for Mamata Para to work out the information in hand. At about 21.25 hrs we arrived at Mamata Para and being shown and identified by the source we held raid at the house of Biplob Mahanta @ Hakar of Mamata Para and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 21.35 hrs to 22.25 hrs on 09.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Biplob Mahanta @ Hakar (45 yrs) S/O late Niresh Mahanta of Mamata Para, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
