With due respect, I am producing herewith the arrested accused persons namely (1) Abdul Rajjak (35 yrs) S/O Ismile Mahammad of Kalangini, Fulbari, PS- NJP, Dist.- Jalpaiguri (2) Md Gofur (21 yrs) S/O late Amirul Mahammad (3) Md Ohidul Ali (21 yrs) S/O late Md Mukim and (4) Bappa Das (18 yrs) S/O Pushnath Das all of Paschim Dhantala, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made hasua and one sharp cutting knife from the possession of accused Abdul Rajjak S/O Ismile Mahammad of Kalangini, Fulbari, PS- NJP, Dist.- Jalpaiguri
2. One iron made Bhojali from the possession of accused Md Gofur (21 yrs) S/O late Amirul Mahammad of Paschim Dhantala, PS- NJP, Dist.- Jalpaiguri.
3. One plastic made charger torch light and one sharp cutting knife from the possession of accused Md Ohidul Ali (21 yrs) S/O late Md Mukim of Paschim Dhantala, PS- NJP, Dist.- Jalpaiguri.
4. One bamboo made lathi and one charge torch light from the possession of accused Bappa Das (18 yrs) S/O Pushnath Das of Paschim Dhantala, PS- NJP, Dist.- Jalpaiguri

I, SI Samik Paul of NJP PS, Siliguri Police Commissionerate beg to state that on 10.07.21 at 00.25 hrs I received a secret source information that a gang of miscreants come to Fulbari Barage with deadly weapons and assembled there and making preparation for committing dacoity at Fulbari area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 464 dated 10.07.21. As per kind order and direction of my superior officer myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Fulbari Barage to work out the information in hand. I also informed the fact to night RT Van officer SI Azizul Hoque and directed him to come at Fulbari Barage to accompany with us. At about 00.45 hrs on 10.07.21 we arrived at Fulbari Barage. After a few time SI Azizul Hoque along with force came to Fulbari Barage and accompany with us. At about 01.15 hrs we found that 10/12 persons assembled in a dark place at below Fulbari Barage and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they had assembled there to commit dacoity in that area.
