As per kind order and direction of my superior officer myself along with ASI Khagen Barman, ASI Sajal Das, Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy left for Fulbari Barage to work out the information in hand. I also informed the fact to night RT Van officer SI Azizul Hoque and directed him to come to Fulbari Barage to accompany with us. At about 00.45 hrs on 10.07.21 we arrived at Fulbari Barage. After a few time SI Azizul Hoque along with force came to Fulbari Barage and accompany with us. At about 01.15 hrs we found that 10/12 persons assembled in a dark place at below Fulbari Barage whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them.
