Sir,

In producing herewith the arrested persons namely 1) Utpal Pramanik (M/32), S/o- Kalipada Pramanik of Bandhu Nagar, Sitaguri, PS: NJP, Dist: Jalpaiguri with one white colour Swift Dezire bearing registration no. WB 73 L/ 9386, 2) Raj Barua (M/27), S/o- Debu Barua of Meteli Bazar, PS: Meteli, Dist: Jalpaiguri with one Maruti Omni van bearing registration no. WB 74 U/ 1561, 3) Avijit Saha (M/32), S/o- Lt. Kanchana Saha of Daukimari, PS- Dhugguri, Dist- Jalpaiguri.

I ASI Amal Debnath of New Jalpaiguri Police Station, Siliguri Police Commissionerate, Siliguri do hereby lodge a written complaint against the above named arrested persons to the effect that on 09/10.07.21 at about 21.45 hrs, while performing Naka duty at Gora More under NJP PS along with CV/436 Kshitish Roy of NJP Traffic Guard, CV/441 Puran Roy, CV/1032 Mocha Karimullah of ICP, Fulbari vide NJP PS GDE No. 451/21, Dated- 09.07.21. During Naka duty, to curbe the spread of Covid-19 by detecting the persons who were loitering in a public place without wearing Face Marks and without any valid reason, as the order has already been promulgated by the Chief Secretary and Chairman, State Executive Committee, West Bengal State Disaster Management Authority vide Memo No. 486-CS/2021 Date: 24.04.2021, Order No. 647-ISS/2M-22/2020 Dated: 15.05.2021 and Memo No. 753/USS/2M-22/2020 Date: 14.06.2021. During Naka Checking found the above named persons are roaming in the area without any valid reason and without wearing face masks violating the Government order. On interrogation they were unable to give any satisfactory replies for roaming in the area without wearing face masks in public place. Further, they were asked to wear face masks and return to their home, but they were reluctant to obey the lawful direction given and started arguing with us. Finding no other alternative, I arrested them U/S 41 Cr.PC after informing them about the ground of arrest. Also seized 1) One white colour Swift Dezire bearing registration no. WB 73 L/ 9386 & 2) One Maruti Omni van bearing registration no. WB 74 U/ 1561 from their possession U/S 102 Cr.PC after preparing proper seizure list duly signed by the witnesses and a copy of seizure list is supplied to them under proper receipt. Later, the seized articles gave them as zimmanama.

Under the above facts and circumstances, it is prayed that a specific case under proper section of law may kindly be started against the above named arrested persons and arrange for its investigation.
