In producing herewith six (6) accused persons namely (1) Tablu Das (20 yrs), S/O Basu Das of Vill-Dangapara, PO. Balaram Hat, PS. NJP, Dist-Jalpaiguri (2) Sushanta Roy (27yrs) S/O. Supen Roy of Vill-Paghalupara, PO. Sahudangi Hat, PS- NJP, Dist-Jalpaiguri (3) Sarmen Roy (28yrs) S/o. Jhuren Roy of Paghalupara, PO. Sahudangi Hat, PS- NJP, Dist-Jalpaiguri (4) Abhijit Mandal (37yrs) S/o. Samar Ch. Mandal of Naukaghat, W/No. 31, PO. Siliguri Bazar, PS. NJP, Dist-Jalpaiguri (5) Md. Noor Hussain (24yrs) S/o. Md. I, ASI. Kajal Charaborty of Ambari Falakata OP under NJP PS/SPC beg to report that on 10.07.2021 in course of morning mobile van duty vide Ambari OP GDE No- 352 dated on 10.07.2021 myself along with force namely (1) C/876 Ram Charan Oraon and (2) CV/001 Joychand Roy both of Ambari-Falakata OP had been to Sahudangi More, under Ambari Falakata OP. PS. NJP to perform in course of Morning mobile van duty I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Tablu Das (20 yrs), (2) Sushanta Roy (27yrs) (3) Sarmen Roy (28yrs) (4) Abhijit Mandal (37yrs) (5) Md. Noor Hussain (24yrs) and (6) Haren Singha (60yrs) and arrange for its investigation.
