In producing herewith one accused persons namely Uttam Rai (49) S/O Lt. Moni Kumar Rai of Ram Chandra Nagar, Behind Vega Circle, W/no-42, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 04(Four) Pouch of Officer's Choice Deluxe Whisky (each Pouch of containing 180 ML)
2. 01(One) Bottle of Honey BEE Premium Brandy (containing 180 ML)
3. 04(Four) Bottle of TUBORG Premium BEER (each bottle containing 650 ML)
4. 01(One) Bottle of KINGFISHER Strong Premium BEER (each bottle containing 650 ML)
5. 04(Four) Bottle of Black Label Strong Premium BEER (each bottle containing 650 ML)

I, SI Sibdhan Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against the above noted accused person to the effect that today i.e. on 14.07.2021 hrs at 19.40 hrs received a source information that house at Ram Chandra Nagar, Behind Vega Circle, W/no-42, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri have gathered huge amount of liquor illegally in the house for selling the same in the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No- 905 dated 14.07.2021. I informed I/C Bhaktinagar about the information. As per his kind instruction I along with ASI Biplab Kumar Das, CVF/ 614 Sumit Kr Roy, CVF/14 Labanyamoy Barman and CVF/619 Dharmendra Roy as proceeded Ram Chandra Nagar to work out the information. At 20.05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid in the house at Ram Chandra Nagar, Behind Vega Circle, W/no-42, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted arrested accused person namely Uttam Rai. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely Dipak Biswas (35) s/o Lt Gopal Biswas of Prakash Nagar, Limbu Busty, w/n-42, PS -Bhaktinagar, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 20.35 hrs to 21.20 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Uttam Rai (49) S/O Lt. Moni Kumar Rai of Ram Chandra Nagar, Behind Vega Circle, W/no-42, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
