
Sir,

With due respect, in producing herewith one arrested accused person namely Pulak Debnath (62) S/o Sri Murari Debnath of Check post, PS Bhaktinagar, Dist: Jalpaiguri along with the following seized articles as per seizure list:

- i] 15(Fifteen) bottles of Kingfisher beer each bottle containing 650 ML.
- ii] 02(two) bottle Mackdowel No 1 whisky containing 750 ML.
- iii] 01(one) bottle Magic Moment Vodka containing 750 ML.
- iv] 01(one) bottle Royal stag whisky containing 750 ML.
- v] 01(one) bottle MacDowell Rum containing 750 ML

I SI Md. Ziaul Haque of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge a written complaint against the above noted arrested accused person. This is to inform you that on 14.07.2021 at around 19.40 Hrs I received a secret source information that the above noted arrested accused person has kept huge amount of liquors at his shop styled as "Popular Dhaba " situated at Check Post, under Bhaktinagar Police Station to sell to the local people for his wrongful gain. After receiving information I along with force ASI Biplab Kr. Das ,CV/614 Sumit Kumar Roy and CV/619 Dharmendra Roy left PS to work out the source information vide GDE No. 906 at 19.55hrs . At around 20.00 hrs I along with force reached at the at the said shop " Popular Dhaba " at Checkpost as identified by the source and held raid and recovered i] 15(Fifteen) bottles of Kingfisher beer each bottle containing 650 ML. ii] 02(two) bottle Mackdowel No 1 whisky containing 750 ML. iii] 01(one) bottle Magic Moment Vodka containing 750 ML. iv] 01(one) bottle Royal stag whisky containing 750 ML. v] 01(one) bottle MacDowell Rum containing 750 ML (Total 14 Ltrs) from his shop. On demand of valid documents in support of recovered liquor he failed to produce the same and stated that he is doing this business since long without any valid licence. On being asked he disclosed his identity as Pulak Debnath (62) S/o Sri Murari Debnath of Check post, PS Bhaktinagar, Dist: Jalpaiguri. At around 20.15 hrs to 20.55 hrs I prepare seizure list of the recovered liquors in presence of available witnesses and arrested the said accused person u/s 41 Cr.P.C. under proper Memo of Arrest after construing the ground of arrest.

Therefore I pray before you to kindly register a specific case against Pulak Debnath (62) S/o Sri Murari Debnath of Check post, PS Bhaktinagar, Dist: Jalpaiguri under proper section of law.
