Sir,

With due respect I would like to inform you that I am the absolute owner in possession of all that piece or parcel of land measuring land measuring 7.2 acres situated under Mouza-Purba Chakchaka recorded in R.S. Khatian No. 96/9 & 75/1 corresponding to L.R. Khatian No. 513, R.S. Plot No. 270/300, 270, 271, 262, 296/318 & 270/335 corresponding to L.R. Plot Nos. 29/71, 270, 270/300, 296/318 & 270/335, J.L. No. 50, P.S. Kumargram, Dist-Jalpaiguri now Alipurduar. Subsequently I came to know that Mr. Shramal Kanti Bose is fraud and cheated so many times in different ways. He never have me the entire documents of Power & others documents inspite of my demand

I have already applied for cancellation / revocation of General Power of Attorney before the District Magistrate Darjeeling & other authorities through email id. As the ADSR offices is closed me.
