**Sub: Written complain regarding theft in my Medical shop**

Dear Sir/Madam,

I would like to draw your kind attention that on 01/07/2021 at about 9.21 P.M. at my medical shop namely GENMED (Dava india Generic Pharmacy) situated at South Deshbandhupara, N.J.P. station road, near pipeline P.O: Siliguri town, Dist: Darjeeling, Pin 734004, two person namely **Mr Surajit pal** with his son namely **Subhrajit pal**, Father's name not known, Address also not known, Mobile no: **9832063274** and **7001251469**, came to my shop for purchasing medicine and other wellness products. Usually they came into my shop in previous occasion also as like other customers. But on 01/07/2021 the said two person by the help of each other wrongfully taken 26 (twenty six) items in the way of theft and the amount of said theft item is Rs 4367/- (Four thousand three hundred sixty seven only). But at that time I am not able to recognize such theft in my medical shop. When I maintain my sale and purchase stock on the next day (02/07/2021), I recognized that I did not sale above mentioned 26 (twenty six) items, then I started watching my CC tv footage of the day (01/07/2021), and I found that above mentioned 26 items were stolen from my medical shop (List are given below) in the way of theft. I also strongly doubt that whenever above mentioned two person came into my shop, they did the same activity. But as my CC tv storage capacity is not beyond 15 days, so I am unable to provide the footage of such previous activities.

It is further mention here that as the above namely persons mobile no is in my previous bill record, so when I call him, first of all, he even not ready to recognize our shop, later on he told me that he will come and pay the amount of stolen items. But after that he again call me and told me that if you want you can go to police station, police will not do any harm to us, literally they are ignoring police dept. I have total call record of that phone call made on the following date i.e. on 02/07/2021 to 03/07/2021 (total 4 times).

So, I came to your police station for recovering my stolen items and please take necessary action against the above mentioned two persons as per law and punished them as per law.
