Respected Sir,

With due respect I, Sri. Subrata Chanda, son of Late Bikash Chanda, resident of 15, Bidhan Road, SMC ward No.11, Siliguri-734001, would like to inform you that my father was the owner of land measuring 0.053 Acre comprised in Plot No. 8840 recorded in Khatian No. 5607 under Mouja- Siliguri, District- Darjeeling by virtue of four separate deeds being Documents No. 1469, 1470, 1471 and 1472 for the year 1984 all registered in the office of the erstwhile Sub- Registrar Siliguri. After intestate death of my father, I and my mother jointly inherited the said land measuring 0.053 Acre according to the Hindu Succession Act, 1956. Thereafter, for development of the said land by constructing a multistoried building we engaged Sri. Dwarka Prasad Golan, as Developer/Promoter of the said land by virtue of Development Agreement dated 02.04.2008. After death of said promoter construction process stopped in an incomplete condition. Subsequently, arising out of a dispute between us and the legal heirs of promoter we revoked the power of attorney on 05.03.2021 before ADSR Kalimpong and cancelled the Development Agreement on 23.01.2021. Now, I resumed construction work in the said land on 25.06.2021. Since then, construction process of the building as per approved building plan is going on peacefully but suddenly said Sri. Sukumar Roy started creating disturbance and today threatened my labours to stop working. Being informed while I interfered in the matter Sukumar Roy threatened me with dire consequences. He assaulted me by pulling my collar and with fist and blow. He snatched Rs. 1,000/- from my pocket. He specifically threatened me that if he is not given a shop room immediately within 7 (Seven) days he will murder me and kidnap my children by engaging goons from Bihar.

It is to mention here that said Sukumar Roy was an occupant of a temporary katcha shop room in our land with whom the deceased promoter had entered into an agreement to settle him in a shop room in the building proposed to be constructed in our land. It is also to mention here that since the Development Agreement and Development Power of Attorney has already been cancelled now, we do not have any relation with the promoter. However, said Sukumar Roy with an ulterior motive to extort money from me creating ruckus in our land and threatened me to stop construction showing an order of Executive Magistrate under section 144 Cr.PC. However, from the said order it is evident that the Ld. Executive Magistrate did not pass any order to stop construction in my land. He is making serious attempt to misuse the order of the Ld. Court which calls for appropriate action against him.
