In producing herewith one accused persons namely 1) Sandip Biswas @ Chotka (43) S/O Sanat Biswas of Bidhan Road near Dolly Inn, Ward No. 12, PS- Siliguri Dist- Darjeeling and 2) Deepjyoti Majumder (27) S/O Bimal; Majumder of Lala Rajpath Roy Road, Ashrampara, Ward No. 14, PS- Siliguri Dist- Darjeeling along with seized articles viz- 1) 100 Pieces of Buprenorphine Lupigesic Injection containing 02 MI each having 1364ASG, Manufacturing date Aug,20,, Expiry date July,22, MRP Rs. 17.60/- marked as Exhibits -A, (2) 104 Pieces of Diazelab Injection containing 02 MI each having batch no. KDZI/001, Manufacturing date 02/20, Expiry date 01/22, MRP Rs. 13.25/- each marked as Exhibits -B, (3) 100 Pieces of Promethazine hydrochloride Injection containing 02 MI each having batch no. NPF0427, Manufacturing date 09/20, Expiry date 08/23, MRP Rs. 11.09/- each marked as Exhibits -C, (4) 05 Pieces of Buprenorphine Lupigesic Injection containing 02 MI each having 1364ASG, Manufacturing date Aug,20,, Expiry date July,22, MRP Rs. 17.60/- each which was taken from Exhibits A as sample, marked as Exhibits A1, (5) 05 Pieces of Diazelab Injection containing 02 MI each having batch no. WB-74 AF/1236 and (8) One Aash color having Pitto back marked as in the body as "XOR Helmets" (9) one white color Samsung mobile phone having IMEI no. 352823093846243, 352824093846241, (10) One black color Samsung S10 having IMEI no. 355332101342358, 355333101342356 as per seizure list to the effect that today i.e 06.07.21 at 20.05 hrs I received a secret information that two persons were busy to sale huge quantity of Drugs to the young boys without prescription at Ashrampara near Ramkrishna maidan under Siliguri PS illegally. I diarised the matter Vide Siliguri PS GDE No. 375 dated 06.07.21 and informed to I/C Siliguri PS. As per direction of I/C Siliguri PS myself along with SI Uday Chakraborty, CV-283 Prosenjit Dey and CV-622 Ramanath Barman left for Ramkrishna maidan under Siliguri PS to verify the veracity of information vide Siliguri PS G.D.E no. 376 dated

06.07.21. At about 20.35 hrs we reached at Ramkrishna maidan, Ashrampara under Siliguri PS. As per identified by source we found that two boys standing on a Royal Enfield Bullet and busy to sale something to the young boys. Accordingly we rushed to the spot and managed to apprehend the above noted persons there by the help of local people.

In presence of the witnesses, on searching, I found that huge quantity of Injection which was kept in a Pitto bag to sale to the young boys without prescription. Then I conducted searched in presence of local witnesses and found that 1) 100 Pieces of Buprenorphine Lupigesic Injection containing 02 MI each having 1364ASG, Manufacturing date Aug,20,, Expiry date July,22, MRP Rs. 17.60/- marked as Exhibits -A, (2) 104 Pieces of Diazelab Injection containing 02 MI each having batch no. KDZI/001, Manufacturing date 02/20, Expiry date 01/22, MRP Rs. 13.25/- each marked as Exhibits -B, (3) 100 Pieces of Promethazine hydrochloride Injection containing 02 MI each having batch no. NPF0427, Manufacturing date 09/20, Expiry date 08/23, MRP Rs. 11.09/- each marked as Exhibits -C, which was keeping in the said Pitto bag and (4) one white color Samsung mobile phone having IMEI no. 352823093846243, 352824093846241, (5) One black color Samsung S10 having IMEI no. 355332101342358, 355333101342356. I interrogated the above noted persons who disclosed their identity as noted above. On demand they could not produce any document in support to carry/selling the above noted Injections and confessed that they procures the same illegally with intension to sale to young boys at Ashrampara near Ramkrishna Maidan under Siliguri PS for their wrongful gain. So I Seized and labeled the above noted mentioned seized articles under proper seizure list in presence witnesses duly signed by the witnesses and arrested the above noted accused persons u/s 41 Cr.PC after issuing Memo of arrest. The seizure and label was made in between 20.55 hrs to 21.50 hrs.

I, therefore, pray to your kind honour that a specific case may kindly be started against accused person namely 1) Sandip Biswas @ Chotka (43) S/O Sanat Biswas of Bidhan Road near Dolly Inn, Ward No. 12, PS- Siliguri Dist- Darjeeling and 2) Deepjyoti Majumder (27) S/O Bimal; Majumder of Lala Rajpath Roy Road, Ashrampara, Ward No. 14, PS- Siliguri Dist- Darjeeling under proper section of law.
