(7605877115),Tapash Rajesh (8695500485). (8597079866), Subrata (6295604781), Sujit (9635057754). They created an advertisement subjecting a velvet coating machine for pencils. Where they offered us the machine at a price of Rs. 80,800/- which included an agreement of 3 years suggesting we were to buy raw materials from them and submit the finish product to them and they would pay us for the processes 0.75 paisa per pencil, addition to the price of that of the raw materials. My payment date was on 30/6/2021, but since 01/07/2021 their company has been closed. I am not able to communicate with any of the associates. Sir almost Rs. 1,50,000/- of my money is been blocked by these men and are unable to find them. I have come across many more people who had been cheated like this and are willing to be my witness.

Sir, please take necessary steps to apprehend the accusers so that I along with the sufferers can get back our due payments and a refund for our machine as they have broken the agreement.

Sir, I beg for your support and strong action against the fraud act.
