

In producing herewith one arrested accused person namely Subal Mandal (45/M) S/O-Lt. Kartick Mandal of-Milanpally, Near RBS Club, Ward No. 26, PS- Siliguri, Dist- Darjeeling along with seized articles (I) 40 (Forty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles St. N-) 01

1. ASI Biswajit Ghosh of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 09/07/2021 at 15:35 hrs during. special raid duty I received a secret source information that, one person is carrying huge quantity of country spirit through Sevoke Road, in front of KFC. Accordingly I informed the information to OC. Panitanki TOF and as per his direction I along with, ASI Gazi Rahaman, C/233 Nagen Ch Barman, CV/1009 Manoj Thakur left for PO to work out the information. On arrival at Sevoke Roads in front of KFC at 15.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 40 (Forty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Milanpally and adjacent area illegally with a view to earn huge money for his lively food. Accordingly I seized 40 (Forty) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 mt each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 15:55 hrs to 16:15 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him Total value of seized articles is Rs. 2000/-

Thence, under the above circumstances I am submitting this written complaint against the above accused person namely Subal Mandal (45/M) S/O-Lt. Kartick Mandal of- Milanpally. Near RBS Clinb, Ward No. 26, PS- Siliguri, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
