In producing herewith 07(seven) accused persons namely (1) Md. I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 09.07.2021 at about 15:45 hrs while performing mobile patrolling duty at Panitanki More area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Md. Sahin (20) S/O Md Mukta Ali of Talul Tala, Majumdar Colony, Ward No. 04, PS-Siliguri, Dist- Darjeeling (2) Rahul Das (28) S/O Ram Das of C/O Mittal Compound, 19 Godawn, PS- Bhaktinagar, Dist- Jalpaiguri (3) Md. Jawed (19) S/O Md. Abdul Jalil of Bhanunagar, (tower), Near Axis Bank ATM, Ward No. 43, PS- Bhaktinagar, Dist- Jalpaiguri (4) Dip Gupta (21) S/O Lt. Debabrata Gupta of Dabgram-II, Balaga Club, Prith Nath PS- Bhaktinagar, Dist- Jalpaiguri (5) Md. Arshad (21) S/O Md. Nashim of Kumartuli, Air view More, PS- Siliguri, Dist- Darjeeling (6) Rakesh Paswan (22) S/O Jagran Paswan of Taitultalla, Majumdar Colony, Ward No. 04, PS- Siliguri, Dist- Darjeeling (7) Md. Asgar (32) S/O Lt. Md. Mustafe of Quarashi Mohalla, Behind Dr. Rajendra Prasad Girls High School, Ward No. 06, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation and unlock period.

Hence they violated the order of Govt. of West Bengal duly promulgated in order No. 753/II-ISS/2M-22/2021 dated 28/06/2021 and No. 647-ISS/2M-22/2020 dated 15/05/2021 read with No 707-ISS/2M-22/2020 dated 29/05/2021 and No. 753-ISS/2M-22/2020 dated 14/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accordingly, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities. Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Md.
