In producing herewith 05 (Five) arrested accused persons who disclosed their identity as (i) Satyam Agrawal (18) S/O Pawan Lal Agrwal of Jalpaimore UCO Bank PS- Siliguri Dist- Darjeeling. (ii) Krishna Nand Yadav (30) S/O Matavar Yadav of Ganga Nagar Road No-02 PS- Siliguri Dist- Darjeeling. (iii) Mantu Roy (20) S/O Nondi Roy of Bhola More Jamurivita PS- Bhaktinagar Dist- Jalpaiguri (iv) Manoj Kumar (46) Shiv charan Mahato of Ranipati PO- Sivaji Nagar PS- Roshra Dist- Samastipur (Bihar). (V) Arun Singh (40) S/O Lt. Kalakdari Singh of Maharaj Colony Road No-02 Ward No-04 PS- Siliguri Dist- Darjeeling.

I, SI. susanta Das of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on 09.07.21 at 19:25 hrs performing Special mobile van duty myself along with force C/1183 Nikhil Saha C/1187 Ganesh Sarkar had been to Mahabirsthan, Khalpara, Siliguri vide Khalpara TOP GDE No-320 dated 09.07.2021 and others and found that the above noted persons and others made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.


Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19.. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
