In producing herewith five (06) arrested accused persons who disclosed their name & identity as (i) Bidyut Biswas (24yrs) S/O- Keshab Biswas of Baghajatin Colony, near Kanchan Jhanga Club, Ward No-2, PS-Pradhan Nagar, Dist-Darjeeling, (ii) Ratan Chowdhury (49yrs) S/O- Lt Nirmal Kr Chowdhury of C/O- Chaitali Das W/O- Rajesh Das of Babupara, near Krishna Kunja Bhawan, Ward No-27, PS-Siliguri, Dist-Darjeeling (iii) Madhab Deb Singha (52yrs) S/O- Lt Baliya Deb Singha of Jyotirmoy Colony, Nichpara, Ward No-32, PS-NJP, Dist-Jalpaiguri (iv) Bhushan Das (45yrs) S/O- Rambilash Das of Giddhatola, Ward No-4, Dhurgaon, Dist-Madhupara, A/P- Santoshi Nagar, near Khataram Mandir, PS-Siliguri, Dist-Darjeeling (v) Khairul Hussain (31yrs) S/O- Abul Kashef Mia of Dabgram Police Housing, Block-D, Room No-11, C/O- Amina Khatun, PS-NJP, Dist-Jalpaiguri (vi) Ranjit Mondal (45yrs) S/O- Lt Biswanath Mondal of Dainhat, near Samajbati Math, Nawapara, Ward No-2, PS-Katowa, Dist-Purbo Bardhaman (vii) Amulya Roy (28yrs) S/O- Ganesh Roy of Central Colony, More Bazar, near Institute Math, PS-NJP, Dist-Jalpaiguri do hereby lodge complaint against the above noted arrested persons to the effect that, on 09.07.2021 at 20.35 hrs during my R/T Mobile Van duty had been to Court More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 & order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accordingly, I arrested above noted persons u/s- 41 Cr.P.C in e/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
