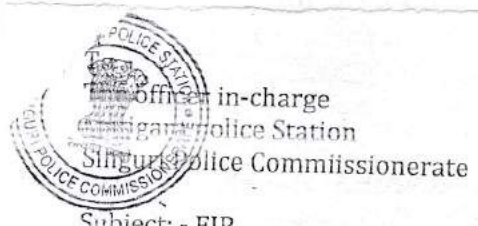

In producing herewith eight (08) arrested accused persons namely (i) Rajbeer Lakra (24), S/O Lt. Sundar Lal Lakra of Tarbanda High School near Auntujote, PS - BDR, Dist - DJG, (ii) Subhajit Singha (22), S/O Aneswar Singha of Dangapara near SSK Schhol, PS - Chopra, Dist - Uttar Dinajpur arrested u/s 41 Cr.P.C.

I, Md. Sanaullah of Matigara PS SPC to the effect that on 15.07.2021 during performing Mobile Van duty at near Barsana Hotel under Matigara PS area he found two persons namely (i) Rajbeer Lakra (24), S/O Lt. Sundar Lal Lakra of Tarbanda High School near Auntujote, PS - BDR, Dist - DJG, (ii) Subhajit Singha (22), S/O Aneswar Singha of Dangapara near SSK Schhol, PS - Chopra, Dist - Uttar Dinajpur were loitering near Barsana Hotel under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Rajbeer Lakra (24), S/O Lt. Sundar Lal Lakra of Tarbanda High School near Auntujote, PS - BDR, Dist - DJG, (ii) Subhajit Singha (22), S/O Aneswar Singha of Dangapara near SSK Schhol, PS - Chopra, Dist - Uttar Dinajpur were loitering near Barsana Hotel under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021 proper section of law and arrange for its investigation.
