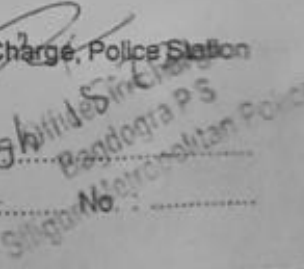

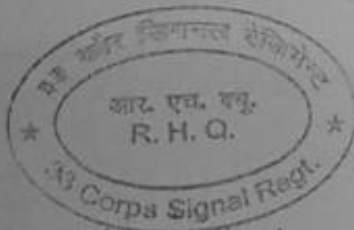

1. I am Major Deepak posted to 33 Corps Signal Regiment from 02 July 2021. My unit vehicle No 04P 016339H was detailed by Station Headquarter on bonafide duty to ferry personal from Sukna Cantt to Bagdogra, airport and back.
2. On 14 Jul 2021, the army bus was driven by Army No 15668693L Havildar Devendra Pal Singh, while coming back from airport. The army bus was hit by civil bus No BR11PB4455 which was trying to overtake at high speed around 1230hr near general area Gossainpur (Railway Bridge). The bus belongs to Sameer Travels (Photos attached). As a result of the collision, the government vehicle has been heavily damaged.
3. Therefore you are requested to lodge an FIR and recover the loss occurred to the government property.
