On Interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Bidhya Chakra Colony and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 35 (Thirty five) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 18:55 hrs to 19:20 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1750/-
