Darjeeling, along with seized (i) 12 (Twelve) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-1,200/- (Twelve hundred) in which 01 (one) bottle taken as sample and marked as Exhibit-"A-1" (ii) 10 (Ten) bottles of Himalaya Gold 60 up Country spirit containing 300 ML in each bottle mentioning M.R.P of Rs-50/- in each bottle i.e. total amount of Rs-500/- (Five hundred) in which 01 (one) bottle taken as sample and marked as Exhibit-"B-1"

I beg to report that today i.e. On 10- 07--.21 while performing special raid against illegal alcohol, at 20.05 hrs, I received a source information that one Raju Shahani @ Machhar (35) yrs, S/O-Late Bishnudev Shahani of Ganda Nagar, Road, No-2, near river side, ward No-5, P.S-Siliguri, Dist. Darjeeling, he is selling huge alcohol in the house of the accd. Person at Ganga Nagar, Siliguri, Under Khalpara TOP-II, without any valid license and documents in higher price than the actual value for his illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who are directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Ganga Nagar, Siliguri, in the house of accused person, P.S-Siliguri, Dist. Darjeeling to verify the veracity of the information vide Khalpara TOP GDE No-370 /21 Dated- 10-07-.21. After reaching at Ganga Nagar, Siliguri at 20.25 hrs and as shown by the source, I found the above noted person are selling liquor secretly to different persons. And seeing the Police party the above noted person try to flee away but we managed to intercept him. On being asked the arrested accused person disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the aced. Person a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business.
