In producing herewith 3 (Three) accused persons namely (1) Bhakti Chick Baraik (28) S/O Lt. Chandan Baraik of Kanchanjangha Stadium Railway Quarter, Quarter No 188/B, PS- Siliguri, Dist- Darjeeling (2) Rup Sonatan Poddar (19) S/O Kingkar Poddar, of Deshbandhupara, S.B. Road, Ward No. 27, PS- Siliguri, Dist- Jalpaiguri (3) Sayan Dutta (24) S/O Sri Swapan Dutta, Of Deshbandhupara, near Star Heith Zim, Ward No. 29, PS- Siliguri, Dist- Darjeeling under arrest.

I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 10.07.2021 at about 21:45 hrs while performing special raid duty at Panitanki More area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Bhakti Chick Baraik (28) S/O Lt. Chandan Baraik of Kanchanjangha Stadium Railway Quarter, Quarter No 188/B, PS- Siliguri, Dist- Darjeeling (2) Rup Sonatan Poddar (19) S/O Kingkar Poddar, of Deshbandhupara, S.B. Road, Ward No. 27, PS- Siliguri, Dist- Jalpaiguri (3) Sayan Dutta (24) S/O Sri Swapan Dutta, Of Deshbandhupara, near Star Heith Zim, Ward No. 29, PS- Siliguri, Dist- Darjeeling

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/II-ISS/2M-22/2020 dated 28/06/2021 and No.647-ISS/2M-22/2020 dated 15/05/2021 read with No 707-ISS/2M-22/2020 dated 29/05/2021 and No. 753-ISS/2M-22/2020 dated 14/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s 41 Cr.P.C in c/w the case after observing all rules and formalities. Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Bhakti Chick Baraik (28) S/O Lt. Chandan Baraik of Kanchanjangha Stadium Railway Quarter, Quarter No 188/B, PS- Siliguri, Dist- Darjeeling (2) Rup Sonatan Poddar (19) S/O Kingkar Poddar, of Deshbandhupara, S.B. Road, Ward No. 27, PS- Siliguri, Dist- Jalpaiguri (3) Sayan Dutta (24) S/O Sri Swapan Dutta, Of Deshbandhupara, near Star Heith Zim, Ward No. 29, PS- Siliguri, Dist- Darjeeling arrange for its investigation.
