With due respect, I Sri. Prashanta Biswas, S/o. Late Satish Chandra Biswas, resident of Bidya Chakra Colony, Siliguri, P.S. Bhaktinagar, Dist. Jalpaiguri beg to state that today on 10/07/2021 at about 10:00 P.M., when I was returning to my house from my work place, some goons namely (1) Ranjit Sarkar, S/o. Khagen Sarkar, resident of Bidya Chakra Colony, P.S. Bhaktinagar, Dist. Jalpaiguri, (2) Biplab Sarkar(Kangaroo), S/o. Late Bipod Bhanjan Sarkar, (3) Manish Mandal (Roni), S/o. Ramananda Mandal, (4) Subhra Saha(Rohit), S/o. Swapan Saha, Nos. 2, 3 & 4 are resident of Janata Nagar, P.S. Bhaktinagar, Dist. Jalpaiguri, who were in drunken condition have wrongfully restrained me at the side of Sanjivani Nursing Home, Ward No. 10, P.S. Siliguri, Dist. Darjeeling and without any reason, they have started to abuse me. Thereafter, due to fear, I have called my own brother Joydeb Biswas and as my house is nearby said Nursing Home, my brother Joydeb Biswas reached at the spot within a minute and tried to save me but the above named Ranjit Sarkar, Biplab Sarkar, Manish Mandal and Subhra Saha have started to assault me and my brother with an intention to kill me. They have suddenly hit my head by an iron rod and for which I sustained grievous injury and fallen down, and by taking such opportunity, they have forcibly snatched the gold chain and locket of my brother and fled away.
