Sir,

In producing herewith 01(one) accused person namely (1) Anil Mitruka (59) S/O Briz Mohan Mitruka of M. D Road, Near Sankar More, Ward No. 09, PS- Siliguri, Dist- Darjeeling under arrest.

I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused person to the effect that on 11.07.2021 at about 11:45 hrs while performing Mobile patrolling duty at Sevoke Road in front of Mirania Brothers and found the above noted arrested person were moving here and there without using face mask. On being asked he disclosed his name as ((1) Anil Mitruka (59) S/O Briz Mohan Mitruka of M. D Road, Near Sankar More, Ward No. 09, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused person by such an act. Finding no other alternative, I arrested him U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted person stated that he was well aware of the Pandemic disaster situation and he was moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation and unlock period.

Hence, he violated the order of Govt. of West Bengal duly promulgated in order No. 753/II-ISS/2M-22/2020 dated 28/06/2021 and No. 647-ISS/2M-22/2020 dated 15/05/2021 read with No 707-ISS/2M-22/2020 dated 29/05/2021 and No. 753-ISS/2M-22/2020 dated 14/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in l/w the case after observing all rules and formalities. Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused person and arranged proper investigation of the case.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Anil Mitruka (59) S/O Briz Mohan Mitruka of M. D Road, Near Sankar More, Ward No. 09, PS- Siliguri, Dist- Darjeeling arrange for its investigation.
