In producing herewith the eighteen (08) arrested accused persons namely;
i) Shiplob Saha (45) S/O Chityaranjan Saha of Ashigarh Colony, PS- Bhaktinagar, Dist- Jalpaiguri, ii) Nirmal Ghosh (40) S/O Niranjan Ghosh of Rabindra Nagar Natunpara, Ward No. 21, PS- Siliguri, Dist- Darjeeling, iii) Dipu Das (32) S/O Purna Das of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling, iv) Swapan Majumder (37) S/O Rabi Majumder of Ambika Nagar, PS- NJP, Dist- Jalpaiguri, v) Babu Ballav (45) S/O Late Jagabandhu Ballav of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling, vi) Adhir Sarkar (45) S/O Late Netai sarkar of Deshbandhupara, near Deshbandhu Club, Ward No. 29, PS- Siliguri, Dist- Darjeeling, vii) Md. Irfan (42) S/O Late Golam Nabir Rasul of Jhankar more. Coal depot, Ward No. 07, PS- Siliguri, Dist- Darjeeling and viii) Lakshikanta Biswas (52) S/O Late Purna Chandra Biswas of Kalamjote near Bridhyashram, PS- Matigara, Dist- Darjeeling along with seized articles seized from the joint possession of the above noted accused persons viz (a) RS 9785/- (Nine thousands seven hundred Eighty five only) as board money, (b) Three (03) sets of playing cards each set containing 52 (fifty two) pieces of playing cards), (c) one plastic made sheet as per seizure list.

I, SI Uday Chakraborty of Siliguri PS lodged a written complaint that on 11.07.21 at 14.30 hrs received an information from secret source over telephone that a gambling with cards is going on inside the house of Sandhya Biswas W/O Late Kalipada Biswas of Sarbohara Colony, ward no. 28 under Siliguri PS and the fact was diarized vide Siliguri PS GDE no. 756 dt 11.07.2021. The matter was accordingly informed I.C of Siliguri PS and being directed by him, I along with SI Hiru Kanti Sarkar, ASI Siben Sarkar, CV/283 Prosenjit Dey, CV/622 Ramanath Barman left for Sarbohara Colony under Siliguri PS to work out the information vide Siliguri PS G.D.E No. 758 dated 11.07.21. At 14.55 hrs reaching and cordoning the house Sandhya Biswas being identified by the source with a strong reason to believe that a illegal gambling is going on inside and managed to apprehend them. Then we found that the above noted arrested persons were gambling with the help of playing cards and money for wrongful gain and wrongful loss to each other inside the above mentioned house. Prior to the entering inside the house we summoned two available local witnesses namely 1) Gouranga Sarkar (54) S/O Late Abinash Sarkar of Lichu bagan, Subhashpally, Ward No. 18, PS-Siliguri Dist-Darjeeling, 2) Dilip Sarkar (46) @ Dilu S/O Dinesh Sarkar of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling,

A/P Rathkhola, Subhash Nagar Colony, Ward No. 22, PS- Siliguri, Dist- Darjeeling and requested them to be present with us during raid. On interrogation they disclosed their identity as noted above.

Accordingly I seized the above noted articles from the joint possession of arrested accused persons named above and arrested them after issuing memo of arrest. The seizure was made in between 15.00 hrs and 15.45 hrs. Then I arrested the above noted accused persons U/S-41 Cr.P.C after observing all sorts' of rules. It is also like to mentioned that the above noted accused person also violated West Bengal Order against Pandemic Covid-19 vide Order no. 486-CS/2021 dated 24.04.21 arising out of order no, 79-SC/2020 dated 12.04.20 and Order no. 647-ISS/2M-22/2020 dated 15.05.21 to prevent spread of Covid -19. The above noted accused person has intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break out of pandemic Covid -19 throughout the country.

I therefore, I pray before your kind end to start a specific case against the arrested accused persons i) Shiplob Saha (45) S/O Chityaranjan Saha of Ashigarh Colony, PS- Bhaktinagar, Dist- Jalpaiguri, ii) Nirmal Ghosh (40) S/O Niranjan Ghosh of Rabindra Nagar Natunpara, Ward No. 21, PS- Siliguri, Dist- Darjeeling, iii) Dipu Das (32) S/O Purna Das of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling, iv) Swapan Majumder (37) S/O Rabi Majumder of Ambika Nagar, PS- NJP, Dist- Jalpaiguri, v) Babu Ballav (45) S/O Late Jagabandhu Ballav of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling, vi) Adhir Sarkar (45) S/O Late Netai sarkar of Deshbandhupara, near Deshbandhu Club, Ward No. 29, PS- Siliguri, Dist- Darjeeling, vii) Md. 
