In producing herewith seven (07) arrested accused persons who disclosed their name & identity as (i) Badal Basfore (20yrs) S/O- Jagadish Basfore of NJP, DS Colony, PS-NJP, Ward No-34, Dist- Jalpaiguri (ii) Chandan Kumar Mahanto (40yrs) S/O- Lt Purna Chandra Mahanto of Purba Milanpally, Ward No-26, near Guru Sweets, PS-Siliguri, Dist-Darjeeling (iii) Annu Kumar Sahani (23yrs) S/O- Srittare Ram Sahani of Pancharam Bridge, near Hanuman Temple, PS-Matigara, Dist-Darjeeling (iv) Prakash Das (21yrs) S/O- Pravat Das of 1 No Dabgram, near Pushpanjali Park, Ward No-23, PS-Siliguri, Darjeeling (v) Narayan Das (25yrs) S/O Sankar Das of Dabgram, Jaikhana Road, Ward No-20, PS-Siliguri, Dist-Darjeeling (vi) Pradip Biswas (45yrs) S/O- Lt Parimal Biswas of Rathkhola, near Bardakanta High School, Ward No-22, PS-Siliguri, Darjeeling (vii) Siraj Ali (32yrs) S/O- Naber Ali of Bakregoli Chak, PS-Lalbagh, Dist-Murshidabad do hereby lodge complaint against the above noted arrested persons to the effect that, on 11.07.2021 at 20.05 hrs during my R/T Mobile Van duty had been to Hill Cart Road area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 and order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
