In producing here with 09 (Nine) arrested accused persons who disclosed their identity as 1) Pranesh Jha (33) S/O- Lt. Chandra Jha of Sitalapara, ward 31, PS- NJP, Dist-Jalpaiguri, 2) Punit Raj (20) S/O-Mukesh Kumar of Harnat PS-Harnat, Dist-Nalanda, Bihar 3) Raja Kumar (23) S/O-Hira Choudhury of Yogatola, P.S-Gardanbag, Dist. Patna, Bihar, 4) Nishan Kumar (21) yrs. S/O-Sheudayar Sahu of do , 5) Santosh Kumar (27) S/O-Ajoy Prasad of Raghobpur PS-Matihari, Dist-Patna, Bihar, 6) Nur Islam (19) yrs. S/O-Md. Samsuddin of Soshiya near Kali Mandir, P.S-Islampur, Dist. Uttar Dinajpur, 7) Md. Samir (25) yrs. S/O-Md. Bohalu of do, 8) Md. Afzal (21) yrs.S/O- Md. Abdul of DO, and 9) Sanjit Barman (41) yrs. S/O-Radhakanta Barman of Stationpara, P.S-Dinhata, Dist. Coochbihar, all the above noted accused persons arrested proper memo of arrest, in c/w above noted case reference.

I, SI Upendra Nath Roy of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that on 11-07-21 at 19.05 hrs, myself along with ASI Uttam Kumar Dhar and force while performing Special mobile van duty at Khalpara, Siliguri, Vide Khalpara TOP-II, GDE No-401/21 dated 11.07.21 and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt. guidelines without any valid reason.

On being asked the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not come out without any valid reason and without valid movement pass issued by the local police authority or civil administration.

Hence, they violated the order of Govt. Of West Bengal duly promulgated in order No-160/C dated 22-07-20 and order No-647-ISS/2M-22/20 dated 15-05-21 and order No-713-ISS/2M-22/2020 dated 31-05-2021 and order No-753-ISS/2M-22/2020 dated 14-06-21. The above noted persons have intentionally refused to comply with the order of Govt. Of West Bengal duly promulgated in view of break out of pandemic COVID-19 throughout the country. Accordingly I arrested them U/S-41Cr.P.C, after issuing proper arrest memo and maintaining health protocols ensure their safety and security and as per order of I/C Siliguri P.S, and O/C Khalpara TOP-II, I released the above noted accused persons after obtaining Bail Bond & P.R Bond.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
