With due respect, I, SMT. PUJA DAS (HALDER), Wife of Sri Biswajit Halder, D/O Sri Biswajit Das, Presently residing at New Colony, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling would like to lodge this written complaint to the effect that Biswajit Halder, Son of Sri Shankar Halder of Rana Nagar Colony, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling is my legally married husband and our marriage was solemnized on 02.11.2015 according to Hindu Rites and Customs on and from Kalibari at Malda. It is to be mentioned here that our said marriage was the outcome of our previous love and affairs and we both of us fled away from our respective houses and married with each other in a Kalibari at Malda and thereafter, the guardians of both the families have accepted our said marriage and subsequently, a social marriage ceremony was also performed. After marriage, we have started to live and cohabited together as husband and wife at my matrimonial house at Rana Nagar Colony, Matigara with other in laws members and we have passed our marital life happily only for a period of few months. After few months of our marriage, I noticed that my husband is a habitual drunker and he used to consume alcohol almost everyday from the early morning of the day. Not only that, my husband spent his income in the gambling and created pressure upon me to bring money from my parental house and on being refusal, he along with his family members inflicted torture upon me both physically and mentally and in spite of the aforesaid torture, I did not lodge any complaint against them for the sake of our happy conjugal life. Just after few months of our marriage, I became pregnant and a female child was born on 19.10.2016 at Progati Nursing Home at Iskon Road, Siliguri whose name is Miss Uttora Halder and after the birth of the female child, the parameter of torture has been increased by my husband and in laws members day by day. My husband went

out from the home in the early morning and return back home in the late hours with fully drunken condition and as and when I raised objection against his such type of activities, he did not bother to assault me physically. My husband and other in laws members have treated me just like a maid in their house and in spite of the aforesaid torture, I used to bear all such type of torture of my husband and in laws members with a hope that in near future they will definitely realize their own mistake and thereby rectify themselves but all my hopes have gone in vain due to the continuous torture of my husband and in laws members. Thereafter, my in laws members driven out me and my husband along with our child from our matrimonial house and finding no other alternative, we have started to reside in a rented premises and even after staying in a rented premises, my husband did not charge his said illegal acts and activities. My husband is also addicted with drugs and contraband articles besides consuming alcohol and on being intoxicated, he has broken all the household articles. In the year of 2017, my husband assaulted me physically in a very bad manner and somehow, I rescued myself with the help of my neighbors and took shelter at my parental house and since in the year of 2017, I have been residing at my parental house with my minor child. During my stay at my parental house, my husband did not bother to take any information about our health and maintenance for myself and my minor daughter and on contrary, he abused and threatened me and my family members with dire consequences and due to such type of threatening of my husband, myself along with my minor female child have been passing our days with extreme fear and anxiety.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal steps against my husband and in laws members as per the provision of law and obliged thereby.
