I, SI Goutam Mallik of NJP Police PS, SPC do hereby lodged this written complaint against the above mentioned two arrested accused Persons to the effect that on 14.07.2021 at 03.05 hrs received reliable secret source information that one Tarikul Siddiki and Md Kabul both of Badlagachh under PS- NJP, Dist- Jalpaiguri purchased huge stolen articles and kept the same at their house. Accordingly, I diarized the matter in GD vide NJP PS GDE No 700/21 Dated 14.07.2021 and informed the fact to you and as per your kind direction myself along with ASI Sajal Roy, VP/08 Laxman Roy and VP/13 Jamirul all of NJP PS left for Badlagachh, PS- NJP, Dist.- Jalpaiguri to verify the veracity of the information. At 03.25 hrs we arrived at Badlagachh and held raid at the house of the above noted two accused persons and managed to apprehended them. During interrogation they admitted their guilt and disclosed that they purchased the above noted articles knowing to be stolen articles. Accordingly, I arrested them under proper memo of arrest and observing all the formalities of arrest. On demand they failed to produce any documents in respect of the above noted articles found from their possession. Hence, I seized the above noted articles under proper seizure list. There was sufficient reason to believe that the above noted articles are stolen one. The search seizure and arrest made in between 03.40 hrs and 05.05 hrs on 14.07.21.

Under the above nopted fact and circumstances, I therefore pray to you that a specific case under propedr section of law may kindly be registered against accused namely (i) Md Kabul S/O Neja Md of Badlagachh, PS- NJP, Dist.- Jalpiguri and (ii) Tarikul Siddil S/O Sahabat Ali S/O Badlagachh, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
