Subject: Criminal Complaint/FIR against Siddharth parik

Respected Sir,

I am the undersigned Vishal Parik, Aged: 33 S/O Ram Kumar Parik residing at Block D17-05, Uttorayon Township, Matigara, PS - Matigara, Dist - Darjeeling, Siliguri - 734010, West Bengal, India. This is to bring under your notice that on 10.07.2021 at 1:00 PM one Mr. Siddharth parik (aged about 26 years) along with one Ms Shweta Parik accompanied by Suman Parik and Radheyshyam Parik were involved in physical assault and criminal intimidation of my Father Mr. Ram Kumar Parik (aged 65 years, a sinor citizen) a patient suffering from diabetics, hypertension and who is being treated for heart related condition since past 4 months.

That the present accused namely Siddharth Parik being aware of the health condition of his uncle/my father/present victim on 10.07.2021 was present at Parik Building, Near Matrisadan Hospital, Kelahati, ward -8 , PS - Siliguri, Dist - Darjeeling, Siliguri 734005, West Bengal. The said building houses the victim's brother'. The victim called the plumber and asked him to shift the motor pump from point A to point B (which is just 4 feet apart). On knowing this At first Siddharth Parik alone, a resident of same building came to the plumber and started abusing him and then the victim arrived at the location and as soon as he arrived he started abusing the victim and pushed the victim and then threatened him with a piece of tile in his hand, which was witnessed by Biman Ghosh (the Plumber), Suman Chandurai (the Plumber's helper) and Gunalan Parthiban (the office staff). Then after this the other 3 one Ms Shweta Parik accompanied by Suman Parik and Radheshyam Parik entered the premises and seeing her son with the tile in his hand started supporting him instead of stopping him. In the process when suman parik came in the middle while the accused had the tile in his hand and the victim tried to move her from the middle, on that they started falsely accusing him of hitting her and Shweta Parik started threatening him falsely that she will call the police and put him to jail on a harassment case. Sidharth Parik has criminally assaulted and confined the present victim under the threat of hitting him with tile in his hand. Due to the physical assault the victim sustained severe injuries. Copy of the Medical Report dated 11.07.21 of injury suffered is annexed hereto and marked as ANNEXURE 'A'.

Siddharth parik also knew the plumbers working at the said site and a abused and physically assaulted the two plumbers Biman Ghosh and Suman Chandurai present at the site along with Mahendra Parik, Kishan Parik, Navin Parik and Gunalan

Parthiban. I am writing this as an initial police report for intimation of the unlawful incident and a crime dated 10.07.2021, at 1:00 PM.

It is not the first time the aforementioned accused and his family have harassed the victim, his family.

The Accused, on an earlier occasion in an intoxicated state once assaulted Mukund Parik and injured his nose, on multiple occasion threatened with a brick in his hand to multiple members of the family and on multiple occasions have harassed, threatened and abused Uma Parik, Kishan Parik and Mahendra Parik.

I urge you to take cognizance of the above-mentioned complaint at the earliest.
