Sir,

I, ASI Rabin Lama of Bhaktinagar PS, Siliguri Police Commissionerate, in receipt of the written complaint against one Suraj Biswas (43) S/O Lt. Binal Biswas of Upper Bhanu Nagar, PS Bhaktinagar Dist. Jalpaiguri under arrest along with the following seized articles:-

- (i) 10 (Ten) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML.
- (ii) 03 (Three) bottles of Kingfisher Beer, each 650 ML.
- (iii) 04 (Four) bottles of Haywards 5000 Beer, each 650 ML.

In this regard, I beg to report that on 17.07.2021 at about 17.45 Hrs. vide G.D.E No. 1083, I along other officer and force while conducting special raid against illicit liquor received an information that a person is selling illicit Liquor in huge quantity in a clandestine way at Upper Bhanunagar under Bhaktinagar PS in the shop of Suraj Biswas house cum shop. As soon as after receiving information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid in the house cum shop of one Suraj Biswas (43) S/O Lt. Binal Biswas of Upper Bhanu Nagar, PS Bhaktinagar Dist. Jalpaiguri and recovered (1) 10 (Ten) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML., (2) 03 (three) bottles of Kingfisher Beer, each 650 ML., (3) 04 (Four) bottles of Haywards 5000 Beer, each 650 ML., (Total- 10.5 Liter) from his house. During raid I found that the above noted arrested accused is possessing the above noted articles and selling it to the customers since long for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses, I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he produced the liquor illegally and had been selling the same illicitly to the people. I, accordingly, seized the above illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper seizure List duly signed by the witnesses and accused, also labeled the same. Then, I arrested him U/S 41 Cr.P.C. The whole process completed in between 18.05 to 18.55 hrs.

As the above noted seized articles are to be suspected be of Illicit Origin and possessing the same illicitly, I, therefore, pray before your kind honour to take legal action against him under proper section of law.
