In producing herewith eight arrested accused persons who disclosed their name & identity as (i) Sagar Kumar (25yrs) S/O- Sunil Kumar of Hakimpara, near Khelaghar More, Ward No-16, PS-Siliguri, Darjeeling (ii) Ajoy Muktan (31yrs) S/O- Amar Muktan of Lower Kaingalia, Bijanbari, PS-Pulbazar, Dist-Darjeeling (iii) Sabyasachi Khatua (34yrs) S/O- Ekadashi Khatua of Dawapukur, PS-Paskura, Dist-Purba Mednipur A/P- C/O-Santu Patra, Laketown, PS-NJP, Jalpaiguri (iv) Partha Kali (40yrs) S/O- Tapan Kali of Hawkers Corner, Ward No-18, PS-Siliguri, Darjeeling (v) Dipu Biswas (18yrs) S/O- Biswanath Biswas of New Cinema Road, Ward No-18, PS-Siliguri, Darjeeling (vi) Md Habib (30yrs) S/O- Md Tahir of Gate Bazar, Ward No-1, PS-Pradhan Nagar, Dist-Darjeeling (vii) Aditya Agarwal (25yrs) S/O- Binod Kr Agarwal of Mahabirsthan, PS-Siliguri, Darjeeling do hereby lodge complaint against the above noted arrested persons to the effect that, on 13.07.2021 at 20.35 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.


On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.


Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 and order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
