In producing herewith one person namely Jiban Mandal, 34 yrs s/o Haripada Mandal of Ranidanga Bazar PO, Ranidanga PS, Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure,

1. 20 (Twenty) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1".
2. 46 (Forty six) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 300 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".
3. 15 (Fifteen) bottle Mr. Dewals No -1 XXX Rum (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1".
4. 12 (Twelve) bottle Strong Kick Can Beer (each bottle containing 500 ml.) marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1".
5. 01 (One) Plastic Container containing 20 (Twenty) liters local made country liquor marked as Exhibit "E" from which 01 liter randomly taken out as sample and marked as Exhibit "E-1". Total illicit liquor seized 54.500 liters.

I, ASI Dharendra Nath Mandal of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person namely Jiban Mandal, 34 yrs s/o Haripada Mandal of Ranidanga Bazar PO, Ranidanga PS, Bagdogra, Dist- Darjeeling to the effect that today i.e, on 17.07.21 at around 14.30 hrs received a reliable source information that one house situated and located at Ranidanga bazaar and they possessing and selling huge quantity of illicit liquor on his house which was located at Ranidanga bazaar area to his designated customers. Accordingly, I shared the information with you and diarized the fact vide Bagdogra PS, GDE no 960 dtd, 17.07.2021 and as per your kind instruction, I along with Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singha all of Bagdogra PS, SPC, immediately rushed to the spot i.e Ranidanga market area the shop under Bagdogra PS, to work out the information. On reaching there at about 15.15 hrs, I contacted with my source and subsequently being pointed the shop seeing the police party some of customers run to fled away somehow we managed to apprehended the above noted person from the house on interrogation he admitted that he is the owner of said house and running the said business since long. I called two local witnesses namely i) Subhankar Mandal s/o Sankar Mandal ii) Subham Mandal s/o Amar Mandal both of Ranidanga bazaar PS, Bagdogra Dist, Darjeeling on request them to remain present during search and seizure and they agreed to remain us and in presence of them we search the above noted huge quantity of illicit liquor has been recovered from his house which was storage and concealed on the house on demand Jiban Mandal failed to produce any valid documents/papers in support of possessing and storing of huge quantity of the illicit liquor. Accordingly, I seized the above noted illicit liquor under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 15.25 hrs to 16.15 hrs. Total illicit liquor seized 54.500 liters.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against Jiban Mandal, 34 yrs s/o Haripada Mandal of Ranidanga Bazar PO, Ranidanga PS, Bagdogra, Dist- Darjeeling and arrange for its investigation.
