This is to inform you that one incident took place in flight 6E 677(CCU-IXB) where in crew informed us that Mr Amarjeet Ray seated on 17A was frequently removing his mask on board and started making personal remarks. Despite crew's request Mr Ray ignored the crews request. He was misbehaving with the crew and he reacted very badly and asked crew to leave by snapping his fingers and started making personal remarks stating woman do not talk in such a manner. Our crew tried to talk him out of it, so that he understands but his colleagues too intervened and started convincing crew that he is mentally unstable and this is how he behaves.

As per the complain of the inflight crew, we handed over the passenger to the local police as he violated the inflight procedures and also a violation of COVID 19 protocols.
