Sir,

In producing herewith one (01) arrested female accused person namely Sapna Mali (26) w/o Sankar Mali of Balupara near Fetepur high School Ps Hilli Dist. Dakshin Dinajpur alongwith following seized articles viz,

- i. One container made up Tin containing said to be Ganja weighing 4 kg and 600 grams wrapped with green colour plastic marked as exhibit- A and the weight of Container 900 grams (including container total weight 5 kg 500 grms) .
- ii. 100 (Hundred) grams of said to be ganja which drawn from exhibit-A as sample for examination packed, sealed, labeled and marked as exhibit-A-1.

I, SI Debabrata Khan of Bhakitnagar Ps , Siliguri Police Commissionerate do here by lodged this complaint against Sapna Mali (26) w/o Sankar Mali of Balupara near Fetepur high School Ps Hilli Dist. Dakshin Dinajpur to the effect that on 18.07.21 at 13-25 hrs received a secret source information that one lady having possession of huge quantity of Ganja was waiting for Bus at Bhuttabari Bagdogra Airport More under P.S- Bagdogra for Balurghat and she could be caught red handed if apprehended immediately. The matter was diarized vide Bagdogra Ps GDE No-1011 dt- 18.07.21. Accordingly, I informed the matter to O.C, Bagdogra PS. As per his instruction myself along with LSI Supriya Barman , ASI Jakurul Islam , C/410 Montosh Singh, VP- 02 Pradip Roy left for the spot at 13-25 hrs to verify the veracity of the information vide corresponding Bagdogra Ps C.C No- 1270 Dt.18.07.21.

At the time of departure from Police Station I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc . On way to spot at Bhuttabari Bagdogra Airport More meanwhile I called two independent witnesses namely [1] Jabbar Ali (60) s/o Lt. Habibar Rahaman of Punai Busty Ps Bagdogra Dist. Darjeeling and 2. Bidhnu nagasia (28) s/o Lt. Kishor Nagasia of Punai Busty Ps Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 13.40 hrs on arrival there by govt. vehicle as identified by the source we surrounded the place and found one lady were standing at Bagdogra Airport More with one Teen box . On being asked she disclosed her identity as noted above. On being further asked she stated that the content inside the tin is Ganja.

After disclosing our identity I asked them whether she wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and she agreed to search by any one. I served her option notice accordance with provisions of law in this regard in writing and she also gave her approval of being searched by any one in writing in the notice serve to her . Accordingly I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sri Manish Kr. Yadav,ACP, Traffic(East), SPC . Accordingly I informed to Sri Manish Kr. Yadav,ACP, Traffic(East), SPC and request to came to the spot. At about 13.55 hrs Sri Manish Kr. Yadav,ACP, Traffic(East), SPC and O.C. Bagdogra Ps arrived at the spot. I disclosed the identity of Sri Manish Kr. Yadav,ACP, Traffic(East), SPC, to the accused person as Gazetted officer and also witnesses. I also offered the independent


esses and the accused person to search our Police Party as per provision of law. But she refused to search the police party. Under supervision of Shri Manish Kr. Yadav, ACP, Traffic(East), SPC and in presence of Independent witnesses I with the help of lady officer conducted searched the detained person following all formalities keeping her decency but nothing could be recovered on her person except wearing apparels. Then searched the container which she was possession and found the above noted seized Ganja kept inside in the said container. On demand in presence of the Gazetted Officer Sri Manish Kr. Yadav, ACP, Traffic(East), SPC she failed to produce any valid document in support of possessing of the Ganja which was kept inside in the Tin. I accordingly weighed the ganja by the weighing instrument and found total 4 kgs 600 grms said to be Ganja wrapped with green colour plastic Marked as Exhibit -A and the weight of Container 900 grms and 100 Grams Ganja taken as sample from the Exhibit -A in one separate plastic packet and marked as A-1. I labeled and sealed all the article in presence of Shri Manish Kr. Yadav, ACP, Traffic(East), SPC Silliguri and independent witnesses and accused person. Then I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Gazetted officer Sri Manish Kr. Yadav, ACP, SPC and acknowledged by the accused person. The seizure was made between 14-25 hrs to 14-45 hrs. On further asked the apprehend person confessed in presence of Gazetted Officer Sri Manish Kr. Yadav, ACP, SPC and other witnesses that she procured the Ganja clandestinely for the purpose of selling in order to earn huge money quickly. On interrogation she disclosed that she had been dealing in such business for last few years importing from Coochbeher, Assam and selling the same to the local area. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to above noted accused person under proper receipt as the accused person violated the terms and condition of NDPS Act possessing Ganja without any authority.


