Sah) son of Mishri Sah 3) Pawan Sah son of Mishri Sah 4) Monib Sah son of late Parayag Sah 5) Chandan Sah son of Monib Sah 6) Chiltu Sah son of Monib Sah 7) Anuj Sah son of monib Sah 8) Bhola Sah son of monib Sah ^{they all are resident of Santoshi nagar netaji road} and 4/5 peoples, they all are residents at different location, they were friends of Chandan Sah. but I don't know these name, they all forcefully enter in the room and broken all the windows and doors and Beat my husband Sanjay Sah and my father in law Bhagwat Sah and my mother in law Kamlawati Devi Sah and me with stick, Iron rod and sharp hammer and my father in law Bhagwat Sah seriously injured and were admitted in Siliguri sub-divisional District hospital Bed no. 19 ward no. male, and my mother in law 14/15 peoples touches hole body and also touch my hole body and my husband Sanjay Sah, 14/15

people tears the clothes of my husband, and they threatened me, they will murder whole family within 2 hours, and they stolen my husband golden ring and cash of 20,140. This incident took 30 min in my house.

I Therefore request you to take action immediately to 14/15 persons and Chandan Sah and Monib Sah and Anuj Sah were the leader of this hole case.
