Sir,

I, ASI. Nitai Mandal of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Bikash Biswa (31/M) S/o Ram Prakash Biswa of Himul Last gate, Nagrujote, PO Nimai, PS- Matigara, Dist- Darjeeling under arrest along with following seized articles viz ; (I) 24 (Twenty four) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-A-1 (Grand total 24X 600 ml.=14.4 Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 17.07.2021 at 22.01 hrs received a secret source information that one person namely Bikash Biswa (31/M) S/o Ram Prakash Biswa of Himul Last gate, Nagrujote, PO- Nimai, PS- Matigara, Dist- Darjeeling has stored huge quantity of illicitly distilled liquor and country spirit at his at his Shop without any valid license. Diarized the matter vide Matigara PS GDE No.974 Dt.-17.07.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with PSI Newton Biswas, Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Himul Last Gate to verify the veracity of the source information. On reaching at the spot at 22:20 hrs it was found that huge quantity of illicitly distilled liquor and Country Spirit stored in the Shop of Bikash Biswa who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the Shop. But we apprehend the above noted person namely Bikash Biswa. There after I called two independent witnesses namely i) Golok Barai (45/M) S/O Lt. Bhim Barai of Shimultala, PO- New Rangia, PS- Matigara, Dist- Darjeeling and (ii) Const- 1035 Santosh Rabi Das of Matigara PS and in the very presence of those witnesses I search the Shop and seized the above noted illicitly distilled liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Bikash Biswa. On being asked the said person failed to produce any document for selling and storing liquor at the Shop. It's a violation under Bengal Excise Act. This seizure was made on 17/07/21 in between 22:25 hrs to 22:50 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Bikash Biswa (31/M) S/o Ram Prakash Biswa of Himul Last gate, Nagrujote, PO Nimai, PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said Shop and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Bikash Biswa (31/M) S/o Ram Prakash Biswa of Himul Last gate, Nagrujote, PO Nimai, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
