In producing herewith six(06) arrested accused persons namely (i) Raju Mandal(22/M) S/O Gouranga Mandal Of Shaktigar, road No-6, PO- Siliguri, PS. NJP, Dist. Jalpaiguri,(ii) Nitai Debnath(38/M), S/O- Lt. Sunli Debnath, of Jalaswari, PO Ghugumali, PS- Bhaktinagar, Dist. Jalpaiguri, (iii) Roshan Ali(24/M), S/O- Md. Kuddus of Paribhannagar, PS. Matigara, Dist. Darjeeling (iv) Md. Munna SK.(33/M) S/O Lt. Md. Habib SK. Paribhannagar, PS. Matigara, Dist. Darjeeling, (v) Satayjit Sha(24/M) S/O Raj Kumar Sha of TIP. Biswas Colony, PS. Matigara, Dist. Darjeeling and (vi) Manaj Roy(20/M) S/O Ajit Roy of Bibekananda Nagar, PO Salugara, PS- Bhaktinagar, Dist. Jalpaiguri, arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made 'Katari' measuring 24 inch (approx) including wooden butt from the possession of Raju Mandal which was kept concealed on his back side,
- (2) One iron made sword measuring 35 inch (approx) including wooden handle from the possession of Nitai Debnath which was kept concealed on his back side,
- (3) One Iron rod measuring 40 inch (approx) in length from the possession of Roshan Ali which was kept on his right hand,
- (4) One iron made sword measuring 30 inch (approx) including wooden butt from the possession of Md. Munna SK which was kept concealed on his back side,
- (5) One iron made Crowbar measuring 36 inch (approx) in length from the possession of Satayjit Sha which was kept on his right hand,
- (6) One iron made Crowbar measuring 25 inch (approx) in length from the possession of Manaj Roy which was kept on his right hand,

I, ASI- Subhendu Das (41), S/O- Lt. Sukumar Das of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Raju Mandal,(ii) Nitai Debnath (iii) Roshan Ali (iv) Md. Munna SK. and (v) Satayjit Sha, and (vi) Manaj Roy others namely Md. Krisimuddin, Md. Basarul SK, Md. Sakir, Avhishek Biswakarma and Md. Lalon to the effect that today on 18.07.2021 at 00.25 hrs received a sources information that 10/12 youths have assembled at behind Chandmani T.E Primary School, under Matigara PS with a view to commit dacoity at uttorayon Township. The fact was diarized in GD vide Matigara PS GDE No- 989, dated 18.07.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Nitai Ch. Mandal, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 00.55 hrs after reaching Chandmani T.E under PS- Matigara I met my source and as pointed by the source we started walking towards Chandmani T.E Primary School. At 01.15 hrs we reaching behind Chandmani T.E Primary School started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted six (06) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Uttorayon Township.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Ramkrishna Para. It is also revealed from them that Md. Krisimuddin, Md. Basarul SK, Md. Sakir, Avishak Biswakarma, Md. Lalon and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Raju Mandal(22/M) S/O Gouranga Mandal Of Shaktigar, road No-6, PO- Siliguri, PS. NJP, Dist. Jalpaiguri, (ii) Nitai Debnath(38/M), S/O- Lt. Sunli Debnath, of Jalaswari, PO Ghugumali, PS- Bhaktinagar, Dist. Jalpaiguri, (iii) Roshan Ali(24/M), S/O- Md. Kuddus of Paribhannagar, PS. Matigara, Dist. Darjeeling (iv) Md. Munna SK.(33/M) S/O Lt. Md. Habib SK. Paribhannagar, PS. Matigara, Dist. Darjeeling and (v) Satayjit Sha(24/M) S/O Raj Kumar Sha of TIP. Biswas Colony, PS. Matigara, Dist. Darjeeling and (vi) Manaj Roy(20/M) S/O Ajit Roy of Bibekananda Nagar, PO Salugara, PS- Bhaktinagar, Dist. Jalpaiguri (vii) Md. Krisimuddin, (viii) Md. Basarul SK, (ix) Md. Sakir, (x) Avhishek Biswakarma, (xi) Md. Lalon and others and arrange for its investigation.
