Sir,

In producing herewith one arrested accused person namely Mangal Muni (42/M) S/O-Thakur Muni of Bidhya Chakra Colony, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles (i) 32 (Thirty Two) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N-)

I, ASI Biswajit Ghosh of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 16/07/2021 at 17:35 hrs during special raid duty I received a secret source information that, one person is carrying huge quantity of country spirit through Sevoke Road, near Dominos. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with, ASI Biswajit Ghosh, C/984 Subhasish Das, C/702 Latifur Rahaman left for PO to work out the information. On arrival at Sevoke Road near Dominos at 17:45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 32 (Thirty Two) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag. On Interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Bidhya Chakra Colony and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 32 (Thirty Two) Bottles of 60 UP Country Spirit styled as Galaxy Boss of 300 ml each when packed, MRP Rs. 50/- each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 18:05 hrs to 18:25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1600/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Mangal Muni (42/M) S/O-Thakur Muni of Bidhya Chakra Colony, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
