I am producing herewith 05 (Five) accused persons namely (1) Arun Agarwal (64/M) S/O-Lt Satya Narayan Agarwal of Pronami Mander Road, Near Kejriwal Hospital, Ward No 13, PS-Siliguri Darjeeling (2) Dhananjay Roy (18/M) S/O-Kshitish Roy of Promod Nagar, Near Parijat School, W/No-42, PS-Bhakti Nagar, Jalpaiguri (3) Md Sahajid (35/M) S/O- Md Elahi, of Ashral Nagar, W/No-42, PS-Bhakti Nagar, Jalpaiguri, (4) Sourav Mitra (M-22), S/O Uttam Mitra of Udham Singh Sarani, Opposite Soubhagya Palace, Panitanki, Ward 13, PS Siliguri, Darjeeling and (5) Pappu Sah (M-38) S/O Ram Sagar Sah of Iskon Manali Road, Sastri Nagar, Ward-41, PS Bhakti Nagar, Jalpaiguri under arrest.

I, SI Arindam Chatterjee of Panitanki Town out Post, PS- Siliguri, and SPC do hereby lodge a written complaint against the above noted accused persons to the effect that today on 17.07.21 at about 18:05 hrs while performing special raid duty at Panitanki More and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Arun Agarwal S/O-Lt Satya Narayan Agarwal (2) Dhananjay Roy S/O-Kshitish Roy (3) Md Sahajid S/O- Md Elahi, (4) Sourav Mitra, S/O Uttam Mitra and (5) Pappu Sah S/O Ram Sagar Sah. On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/III-ISS/2M-22/2020 and order No-753/II-ISS/2M-22/2020 dated 28/06/2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested them u/s- 41 Cr.P.C. after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Arun Agarwal S/O-Lt Satya Narayan Agarwal (2) Dhananjay Roy S/O-Kshitish Roy (3) Md Sahajid S/O- Md Elahi, (4) Sourav Mitra, S/O Uttam Mitra and (5) Pappu Sah S/O Ram Sagar Sah and arrange for its investigation.
