Sub: FIR against Sri Joydeep Kumar Saha for Physical Assault and Attempt to Murder

Dear Sir,

I, Jayanta Kr. Saha, S/o - Late Jugal Kishore Saha, resident of Dr. Kalinath Road, Khalpara, Siliguri-734005 which is within the jurisdiction of your esteemed police station and the complainant's name is Sri Joydeep Kr. Saha, S/o - Late Jugal Kishore Saha, resident of Dr. Kalinath Road, Khalpara, Siliguri-734005 and the present complaint is being filed as -

1. My father namely Shree Jugal Kishore Saha expired nearly four years back leaving my mother, a sexagenarian being 62 years of age as widow and two sons namely Sri Jayanta Kr. Saha (elder son) and Sri Joydeep Kr. Saha (younger son).
2. We have a family partnership business under the name and style M/s - Jagdish Ch. Saha (Rice Wholesale) and M/s - Sanjeev Flour Mill (Besan Manufacturing) wherein I along with my mother Smt. Krishna Saha, my brother Sri Joydeep Kr. Saha and my uncle Sri Sanjib Saha are the partners.
3. Being a Working Partner in the said businesses he has taken unilateral charge of the accounts of the business and has syphoned off about Rs. 35 Lacs (Rupees Thirty-Five Lacs) from the said business without the knowledge and consent of me or my mother as partner. In spite of my repeated request, he deliberately refused to disclose the accounts of the said business. Whenever I had asked for my profit share out of the said business, he has been hysteric and started abusing me with filthy language and threatened to kill me.
4. On 15-Jul-2021 around 11:50 pm, Sri Joydeep Kr. Saha returned home and started yelling on my mother questioning my involvement in business and certain accounting information that I had shared with my uncle and his elder daughter. When I requested him not to threaten my mother on same, he started yelling at me and soon became violent and began kicking and hitting. He hit me badly to my head (Medical Report has been attached) and threatened to kill me if I don't stop intervening and questioning his habit of illegally withdrawal of money from the said businesses.
5. In spite of the intervention of my mother, Smt. Krishna Saha, my uncle Sr. Sanjib Saha and Sri Joydeep Kr. Saha's wife Smt. Sarmistha Saha, who witnessed the whole incident, Sri Joydeep Kr. Saha kept me hitting.
6. A complaint of same nature was submitted by me to your esteemed office on 28-Apr-2021 copy of which is attached herewith for your ready reference.

8. In such context, as a single unmarried person, me and my mother's peaceful leaving in our house is completely disturbed. I am feeling unsecured and leaving with fear of being killed by him at any moment.
9. In view of the above, it is prayed that an FIR may kindly be registered and the accused be arrested and brought to the books and tried as per law to save my right of peaceful leaving.
