factory) beg to respectfully inform you that i am a
business man by profession, my office is in just below
my house, yesterday on dated 17/07/2021 at evening
about 07:00. 'o'clock' it was raining heavily, like every
day i was sitting in my office. It rained heavily
& the road was decorated, when i saw 2 persons
stopped in front of my office on a motorcycle, come
to my office & started telling me, that Mr. Ashok
you have become a very big leader of B.J.P
Party, he appointed a gun at me, i was shocked & very
scared & they started asking for money. i handed
over 20,000 & kept in the office, after that one of
them grabbed my collar & took out the gold chain from
my neck, i was shocked, he forcefully took my gold ring
from my hand, another one took my mobile phone
model (One plus) (98320-13014/9002-33567), i was panicked
they said something, he kill me. i have been a political
functionary, they were talking in Bengali language, their
physical appearance was about 5 feet 10 inch tall
& strong by body, they wearing helmet, full shirt
jeans, because of helmet i didn't see his
face, but i realized that he has already
allowed me. One of them even asked to shoot
me.
