I, SI. Kamal Saha of Ambari Falakata OP under NJP PS/SPC beg to report that on 18.07.2021 in course of evening mobile van duty vide Ambari OP GDE No-592 dated on 18.07.2021 myself along with force namely (1) C/1058 Jayanta Debnath and (2) NVF-159 Debranjana Sarkar both of Ambari-Falakata OP had been to Canel More, under Ambari Falakata OP. PS. NJP to perform K-39 van duty in course of evening mobile van duty I found the above noted persons were roaming without face mask at that area and violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they refuse to comply with direction of regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) SK Ershed(31 yrs) S/O SK Jatru, of Puratan Polly, PO+ PS. Islam Pur, Dist-Uttar Dinaj Pur (2) Saddam Hossen (29yrs) S/O. Md. Hamidul Rahaman of Gunjaria Bazar, PO+ PS. Islam Pur, Dist-Uttar Dinaj Pur (3) Md. Sabbir (28yrs) S/o. Jamaruddin Md of Gunjaria Bazar, PO+ PS. Islam Pur, Dist-Uttar Dinaj Pur (4) Bapi Das (29yrs) S/o. Dodiram Das of Ashighar More, PO. Ghoogomali, PS.
